# SUBHAUL AGREEMENT

This agreement made and entered into between N. M. Griggs Company Truck Lines and  
, **SUBHAULER.**

**Agreement as follows:**

1. SUBHAULER owns the vehicles used and agrees to maintain and keep said vehicles in good order and pay all expenses, including fuel, wages of the drivers and insurance against public liability, property damage, fire, collision, loss of cargo and workmen's compensation. Griggs Company does not have the right to inspect the said vehicle for safety checks. It is solely the responsibility of the SUBHAULER.
2. The drivers of said vehicles shall at no time be employees or permanent SUBHAULERS of Griggs Company. SUBHAULER has a right to accept return loads without the permission of Griggs Company. SUBHAULER has the right to refuse a load requested by Griggs Company.
3. SUBHAULER will operate his/her vehicles under the jurisdiction of his/her licenses and not under Griggs Company's licenses. SUBHAULER'S vehicles will not carry the name of Griggs Company.
4. SUBHAULER shall be conclusively deemed to be exclusive control of said vehicles and equipment. The information provided to the SUBHAULER by Griggs Company will only be informational not instructional except to inform SUBHAULER of customer's instructions which SUBHAULER will use his best efforts to comply with.
5. Any claims against the shipment because of damage, shortages or delay in transit will be for the account of the SUBHAULER. SUBHAULER shall pay all costs and expenses incidental to the performance of such transportation service.
6. SUBHAULER agrees to hold Griggs Company free and harmless from all claims, loss or damages on account of injury to or death of persons or damages to property caused or alleged to be caused by or in connection with the operation of equipment belonging to or used by SUBHAULER.
7. SUBHAULER'S compensation shall be on a per load basis. SUBHAULER agrees to return all signed proofs of delivery and related paperwork to Griggs Company in a timely manner. Griggs Company will perform billing and collecting services and will pay over to the SUBHAULER the amount agreed upon.
